This privacy policy explains how we use any personal information we collect about you when you use our website or wider services.

By using the website and our wider services you consent to this policy. Integrated Pest Management Ltd are not required to register with the Information Commissioner's Office for this purpose.

### Information we collect

We will only collect personal data via our website or via our customer service-desk if it is directly provided to us by you the user, e.g. your e-mail address, name, home or work address and telephone number, and therefore has been provided by you with your consent. Normally you will only provide such details if you wish to use our wider resources or are making a purchase from us.

We also use analytical and statistical tools that monitor details of your visits to our website and the resources that you access, including, but not limited to, traffic data, location data, weblogs and other communication data (but this data will not identify you personally).

### Use of your information

We may hold and process personal data that you provide to us in accordance with the DPA and GDPR.

## Disclosure of your information

We may disclose your information to regulatory bodies to enable us to comply with the law and to assist fraud protection and minimise credit risk.

We will not share your data to third parties for marketing purposes.

## Controlling the use of your data

## Where we store and transfer your data

If we transfer or store your personal data outside the EEA in this way, we will take steps with the aim of ensuring that your privacy rights continue to be protected under GDPR, as outlined in this privacy policy and in accordance with the DPA and GDPR. We do not use or disclose sensitive personal data, such as race, religion, or political affiliations

We may disclose your personal data outside of our group: (a) in the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets; and (b) if Integrated Pest Management Ltd business is bought by a third party, in which case personal data held by it about its customers will be one of the assets to transfer to the buyer.
